2011 SCHOOL ELECTION

PUBLIC NOTICE IS HEREBY GIVEN that the regular school election for the West Delaware County Community School District, in the County of Delaware, State of Iowa, will be held on Tuesday, September 13, 2011.

Polls will be open from 12:00 pm (Noon) until 8:00 pm. Pre-Election Day voter registration, for this election, will close Friday, September 2, 2011 at 5:00 pm. It is highly recommended that those persons wishing to vote in this election pre-register on or before the September 2, 2011 deadline. However, in January 2008, Iowa law was adopted to allow eligible persons the right to register to vote and cast a ballot on Election Day if they are able to provide proof of both their identity and residency at the polls. Please bring a valid and current photo ID which has an expiration date. If the address on your ID is not current, you will need to prove residency. The following documents can be used as proof of residency if they contain your name and current address: Residential lease, Property tax statement, Utility bill, Bank statement, Paycheck, Government check or other Government document. If you do not have proof of residence and identity, a registered voter in your precinct may attest for you. You will both be required to sign an oath. To request an absentee ballot, use the official form available at the Delaware County Auditor's Office, or at the county's website at [www.co.delaware.ia.us](http://www.co.delaware.ia.us) or at the Secretary of State's website at [www.sos.state.ia.us](http://www.sos.state.ia.us), and mail it to the Delaware County Commissioner of Elections, 301 E. Main St., Room 210, Manchester, Iowa 52057. The last day to request an absentee ballot by mail is Friday, September 9, 2011 at 5:00 pm. In person absentee voting is available at the Delaware County Auditor's Office thru 11:00 am on Tuesday, September 13, 2011. The precincts and polling locations for the West Delaware County Community School District will be as follows:

Precinct #1 - Dundee Community Center for the City of Dundee and that part of Richland Township that is in said district.

Precinct #2 - Masonville Fire Station for the City of Masonville and that part of Coffins Grove Township in Delaware County that is in said district and that part of Fremont Township in Buchanan County that is in said district.

Precinct #3 - Ryan City Hall for the City of Ryan and that part of Adams Township and Hazel Green Township that is in said district.

Precinct #4 - Seibert Park Memorial Hall, Manchester, Iowa for Manchester 3<sup>rd</sup> Ward, and that part of Oneida Township, Prairie Township, Milo Township and Delaware Township that is in said district.

Precinct #5 - Greeley Fire Station, for the City of Greeley and that part of Honey Creek Township and Elk Township that is in said district.

Precinct #6 - Manchester Fire Station, Manchester, Iowa for Manchester 1<sup>st</sup> and 2<sup>nd</sup> Wards.

All polling places designated for use in this election are accessible to persons with disabilities. Any voter who is physically unable to enter a polling place has the right to vote in the voter's vehicle.
